My name is \_\_\_\_\_ and I live in \_\_\_\_\_ School District. I am reaching out to you because I am deeply concerned about the fact that inequitable and inadequate education funding is harming my children and their classmates.

As a parent in an underfunded school, I can see that our children are not being given the same educational opportunities as children in neighboring districts. We have fewer classes like foreign language, sciences, and AP courses. Lack of resources has also limited the opportunities to participate in co-curricular activities in the areas of music, dance, and athletics.

To add insult to injury, I recently became aware of the fact that 78% of children of color in Pennsylvania attend underfunded schools while the majority of their white peers enjoy the benefits of attending schools with more resources.

I find the inadequate and inequitable funding of our schools to be unjust, unethical, and immoral. Our children are being discriminated against and robbed of the educational resources they need to prepare to become a successful people and good citizens.

I see that Gov. Wolf's recent 2021 Budget Proposal calls for a substantial increase in state education funding for K-12 grades as well as to fairly distribute most of this money through Pennsylvania's bipartisan Fair Funding Formula. This will be a great step forward in ending the inequity in the distribution of state education dollars.

Equitable education funding can no longer be seen as optional. We are calling on you to give our schools the resources they need and run all education funding through the fair funding formula.

I'm reaching out to you because every day I see firsthand that my students aren't receiving the educational resources they need.

Pennsylvania has the widest gap in the nation between spending in wealthy districts versus poor districts. This gap is fueled in part by the state legislature's inequitable funding method.

I teach in a school district that is underfunded by millions of dollars in state funds every year. These are funds that could provide more teachers to reduce overcrowded classrooms, repair deteriorating old facilities, provide updated curriculum including advanced courses and support for students with social emotional needs.

I see that Gov.
